



## EARLY BIRD PROGRAM INFORMATION

The Boys & Girls Clubs of Whatcom County, Ferndale Branch, will offer fee-based, before school programming: Early Bird Program. This program serves elementary school students from Eagleridge, Cascadia, Skyline and Central, ages 1st-5th grades, from 7-9 am. This program includes transportation to schools outside of walking distance.

### EARLY BIRD REGISTRATION

Pre-registration is required for Early Bird Program. By registering your child, you are registering for the entire school year, at a rate of **\$125/month**. **Payment for the first month is due at time of registration.**

### COST

There are two basic rates, monthly and drop-in. Drop-ins are restricted to Central Elementary School students only since we walk those students to school; they must be current Club members. Drop-in visits are limited to *four a month*.

DROP-IN	\$15 per child per day (Central Elementary Students only)
MONTHLY	\$125 per month per child

### TRANSPORTATION

The Boys & Girls Clubs of Whatcom County, Ferndale Branch, is limited to 30 spaces for children who need transportation to school for Eagleridge, Cascadia and Skyline. We have unlimited space for children who attend Central Elementary

### BILLING

Club Members who are registered will have their accounts charged the first day of the month, and families will have the first FIVE business days of the month to pay in full. Any delinquent accounts will result in suspension of access to the Early Bird Program. Members with past due accounts will not be able to attend the Early Bird program, but will still be able to attend after school. Please contact the Club Director if you have payment questions.

### CANCELLATION

If you wish to discontinue the program, you will need to notify the Branch Director in advance to avoid any other charges, as it is the policy of the Boys & Girls Clubs of Whatcom County to not issue refunds. Program fees will not be prorated.
